Leon Botstein Launches Twentieth Anniversary Celebration!

OLLI's twentieth year anniversary celebration will officially kick off with a lecture by Dr. Leon Botstein on Sunday, September 8, at 2 p.m. in the Daniels Arts Center of Bard College at Simon's Rock. Dr. Botstein, who previously spoke at the 1999 convocation of our predecessor organization, Berkshire Institute for Lifetime Learning (B.I.L.L.), has been president of Bard College since 1975. He is also the Leon Levy Professor in the Arts and Humanities.

Under his leadership, Bard College has become a premiere American educational institution with a successful network of innovative public high schools as well as a global presence



with joint-degree programs across the globe. Dr. Botstein is also chairman of the board of the Central European University and a board member of the Open Society Foundations.

Dr. Botstein, a conductor of international renown, has been music director of the American Symphony Orchestra since 1992. He is co-artistic director of the acclaimed Summerscape and Bard Music Festivals at Bard College and conductor laureate of the Jerusalem Symphony Orchestra, the state radio orchestra of Israel, where he served as music director from 2003 to 2010.

His essays for the Bard Music Festival, published by Princeton, are

soon to be anthologized. A sequel to his earlier book, *Jefferson's Children: Education and the Promise of American Culture* (1997), is forthcoming.

The lecture is free and open to the public. — Barbara Hochberg

Annual OLLI Meeting and Mona Sherman Memorial Lecture

OLLI's annual meeting and the fifth Mona Sherman memorial lecture were held on Friday, June 7, at The Colonial Theatre in Pittsfield. OLLI's President Sandra Rubin introduced Artistic Director and CEO of the Berkshire Theatre Group Kate McGuire who welcomed OLLI members and praised Mona Sherman's considerable contributions to the BILL/OLLI community. Kate McGuire encouraged the audience to attend the Berkshire Theatre Group's events scheduled for the coming season.

Sandra Rubin then began the business portion of the meeting. She noted that 2012/2013 has been an excellent year that saw the achievement of two major goals: the launching of OLLI's Leadership Development Program and the growth of OLLI's annual fund donations—which were up 66 percent from last year! She also cited Special Events, the Distinguished Speakers Series and OLLI's catalogs and newsletters as major contributors to this growth, along with the excellent course offerings. Sandra thanked the volunteers for their enthusiasm and vigor.

Treasurer Norman Michaels presented the financial report for the ten months ended April 30, 2013. He outlined OLLI's financial status for that period, noting that it is better than at the same time last year. The operating account balance sheet ended with \$31,375 in equity. The endowment account ended with \$2,146,613 in equity. The total equity was therefore \$2,177,988. The income statement for the same period showed a net income of \$812 in the operating account and \$84,767 in the endowment account for a total net income of \$85,579.

He emphasized that we cannot touch the \$2 million endowment. We can only use the income earned from it. Norman said that we need \$100,000 a year in earnings from the endowment account to operate the organization. Dues, tuition and income from the Distinguished Speakers Series and Special Events

pay for the operations of OLLI. The earnings in the endowment account pay the salary and benefits for a full-time executive director.

Norman Michaels explained that the income from the endowment account for the ten months ended April 30, 2012, was \$47,267. In the current fiscal year that number is \$159,176. He hopes that the income for the two years ending June 30, 2013, will average \$100,000 per year. He urged members to consider making monetary contributions to OLLI in order to keep OLLI healthy.

Next, Executive Director Barbara Hochberg outlined plans for the coming twentieth anniversary celebration beginning in September 2013 with a keynote address by Leon Botstein, president of Bard College, and concluding with a celebratory event at the Cranwell Resort in May 2014.

Barbara thanked retiring Board of Directors member Carole Siegel for her contributions to the board, for the insights she provided and for the work she did to develop and implement OLLI's Mentoring Program with BCC. In addition, Barbara acknowledged BCC's President Ellen Kennedy and Vice President of Community Education & Workforce Development at BCC Bill Mulholland. She thanked the 200 plus volunteers who support OLLI. Barbara emphasized the importance of a vibrant, active membership

in BILL/OLLI's growth since its founding in 1994.

Sandra Rubin then proceeded with the next order of business. Two resolutions to amend OLLI's bylaws were read, voted upon by the membership and approved. She then presented the slate of directors for the coming year which was approved unanimously. Sandra thanked departing board member Carole Siegel and welcomed the newly elected members to the board. (See Board of Directors list on page 2.) The business portion of the meeting was closed.

Over 250 people attended and heard the keynote speaker, Douglas Brinkley, Ph.D., award-winning author, historian and professor of history at Rice University, deliver an entertaining and perceptive lecture on his latest book *Cronkite*. Brinkley spoke for over an hour describing Walter Cronkite's childhood in Missouri and Texas, his early years as a reporter for International News Service, his service as a reporter embedded with the 8th Air Force in England during World War II and finally his position as anchor of the CBS Evening News. Brinkley's lecture included the social and political era that Cronkite reported on during the 1960s and 1970s. He concluded: "In an era when no one trusted anyone anymore, Cronkite was trusted and liked. He never wore out his welcome."





Women Educators of Berkshire County

THE HINSDALE HALL FAMILY OF PITTSFIELD

Nancy Hinsdale (1769-1851), whose portrait hangs in the Berkshire Athenaeum's local history room, founded Pittsfield Female Academy in 1800. It was the commonwealth's first private school for girls and over the nineteenth century had several owners and sites. In 1898, it became Miss Hall's School when Mira Hinsdale Hall, Nancy Hinsdale's great-niece, bought and established it in her name.

In 1909 Miss Hall moved the school from Bartlett Avenue to its present location on Holmes Road. The school grew in reputation and Miss Hall became nationally known as a progressive educator of young women. In recognition of her success as the founder and principal of a great school, she was awarded an honorary L.H.D. (Doctor of Humane Letters) by her alma mater, Smith College. Presenting the award in 1933 at the fiftieth anniversary of her graduation, the president of Smith said, "Miss Hall has maintained the highest level of scholarly achievement demanding upon all the best they have to give." Striving for excellence and holding to lofty ideals of honor, character building and integrity were her life-long goals.

During her forty-year tenure as headmistress, Miss Hall also became involved in community, cultural and religious affairs and for a number of years gave \$1,000 annually to the city of Pittsfield in lieu of taxes. She faced tragedy and a challenge in 1923 when a fire destroyed the school. No students were injured, but an employee died. Miss Hall was determined to rebuild and was supported by the local community, particularly Winthrop Murray Crane, Jr., who became president of the newly formed school corporation. The new building opened in 1924.

Mira Hinsdale Hall was born in Le Roy, New York, in 1863. The daughter of Charles and Elizabeth Hinsdale Hall; her mother was a descendant of

the Reverend Theodore Hinsdale family, for whom the town of Hinsdale is named. Miss Hall was educated in a private school and after graduation from Smith taught English and Latin. She died suddenly in 1937 while on vacation in Maine.

Her niece, Margaret Hinsdale Hall, who was her assistant, succeeded her as headmistress.

Margaret Hinsdale Hall, born in 1892, was a major founder of the Berkshire Historical Society. Her dream was to form a society to collect and preserve newspapers, circulars, all kinds of history and memories for public use. In 1962 she gave her large collection to form the Margaret Hinsdale Hall Library of the Berkshire



Historical Society, now headquartered at Arrowhead in Pittsfield. She died in 1966 while attending a meeting of the society.

In the Land of Milk and Honey: The Struggle in the Jewish Soul by Inge Kuenkler-Etzbach, published by Almvillabooks, 2012

Why would the children of the Holocaust (who had suffered the depth of despair and cruelty themselves) treat another people with such a lack of compassion? This book focuses on the archeological discoveries and interpretations which reveal the Jewish right to the Land of Israel as based on myths instead of historical facts. It also reflects voices and opinions of people courageously speaking up for a new Jewish identity.

Mountain Ash: A New England Memoir by Elna Fone Nugent, published by Xlilbris Corporation 2008

Early on, a neighborhood tragedy impacted the author so personally it induced a relentless lifelong quest to discover what we are doing here on earth and why. Getting married and moving to the Berkshires initiated a breakthrough-of-consciousness experience at thirty-seven years of age when the author rose from the ashes of a dark period in her life and allowed her to discover answers to the questions she had—answers that she needed.

In Silence: Growing Up Hearing in a Deaf World by Ruth Sidransky, published by St. Martins Press, 1990; published by Random House, 1992; republished 2006

This book is the author's account of growing up as the hearing daughter of deaf parents in the Bronx and Brooklyn during the 1930s and 1940s. It reveals the challenges deaf people faced during this period and provides a living narrative of the deaf experience in America. It is a story

of a family bound by an invisible handicap, deafness, and the lack of spoken language for a hearing child. *The New York Times* called *In Silence* a great act of love, and the work has been translated into several languages.

Richard Matturro is the author of three contemporary novels all published by Livingston Press: *Luna* (2006), *Janey* (2012) and *Leslie* (2008) which comprise his Tri-City Trilogy—three novels set in the neighboring upstate New York cities of Albany, Schenectady and Troy; three women who share an aversion to all things female, especially motherhood; three detours to the place where myth and reality collide. He is also the author of three novels of the ancient world: a comedy, *Perseus* (Livingston Press 2010), a history, *Troy* (Walker Books 1989) and a tragedy, *Medea* (Livingston Press out in the spring of 2014).
